

ORDINANCE NO. #005-06

**AN ORDINANCE OF THE CITY OF DE LEON, TEXAS,
CANVASSING THE RESULTS OF A GENERAL ELECTION FOR
MAYOR, PLACE ONE, PLACE TWO; A SPECIAL ELECTION
FOR REMAINING TERM OF PLACE FOUR**

WHEREAS, an election was held in the City of De Leon, Texas on May 13, 2006 for the purpose of the General Election of Mayor, Place One and Place Two Council members.

WHEREAS, an election was held in the City of De Leon, Texas on May 13, 2006 for the purpose of the Special Election of Place Four Council member.

WHEREAS, the City Council has reviewed and investigated all matters pertaining to this election, including the ordering, notices, election officers, holding and returns thereof; and

WHEREAS, the City Council hereby canvasses the returns of this election, at which there was submitted to all resident, qualified electors of the City of De Leon for their action thereupon, the General election of Mayor, Place One and Place Two Council members.

WHEREAS, the City Council hereby canvases the returns of this election, at which there was submitted to all resident, qualified electors of the City of De Leon for their action thereupon, the Special Election of Place Four Council member.

WHEREAS, the City of De Leon has diligently inquired into the poll lists and the official election returns which were duly and lawfully made to this Board by the judges and clerks holding and conducting the election; the poll lists and the official election returns showing separately the votes cast in the election; and

WHEREAS, from these returns, this City Council hereby finds that the following votes were cast in the election by voters who were resident, qualified electors of the village; and

THEREFOBE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DE LEON, TEXAS,

SECTION 1. The City Council officially finds, determines, and declares that the election was duly and properly ordered, that proper legal notice of such election was duly given in the English language and the Spanish language, that proper election officers were duly appointed prior to the election, that the election was duly and legally held, that all resident, qualified electors of the City of De Leon were permitted to vote at the election, and due returns of the results of the election had been made and delivered, and that the City of De Leon has duly canvassed such returns, all in accordance With the laws of the State of Texas and of the United States of America and the resolution d i n g the election.

SECTION 2. The following person is elected to the City of De Leon as Mayor for a term of two (2) years:

SECTION 4. The following person is elected to the City of De Leon as Council Member for the term of one (1) year:

SECTION 5. Pursuant to Article VII, Section 10, of the Charter of the City of De Leon, the requirement for the reading the ordinance at two (2) meetings of the City Council is waived.
